1677. Imminent rapture and end of Tribulation

The unraveling of the mystery hidden in the Bible until this time, the time of the end started when I noticed that the timing of the start of the Tribulation period was given in Dan. 9:24-27 and that according to that scripture it was set to start 49 years after the command to restore Jerusalem, which was given after the 6 day war, on June 28th 1967 [Article 1598: The Tribulation began in 2016].

²⁴ "Seventy ^[e]weeks are determined For your people and for your holy city, To finish the transgression, ^[f]To make an end of sins,

To make reconciliation for iniquity, To bring in everlasting righteousness, To seal up vision and prophecy, And to anoint ^[g]the Most Holy. ²⁵ "Know therefore and understand, That from the going forth of the command To restore and build Jerusalem

Until Messiah the Prince,

There shall be **seven weeks** and **sixty-two weeks**;

The ^[h]street shall be built again, and the ^[i]wall, Even in troublesome times. (Dan. 9:24-25)

There are 70 weeks, the True Messiah comes after 62 weeks and the false Messiah comes after 7 weeks or 49 years, from the command to restore Jerusalem. The True Messiah is cut-off not for Himself and people of the Prince that is to come, destroy the city and the Temple, something which occurred in 70 AD.

²⁶ "And after the sixty-two weeks Messiah shall ^[j]be cut off, but not for Himself; And the people of the **prince who is to come** Shall destroy the city and the sanctuary. The end of it shall be with a flood, And till the end of the war desolations are determined. (Dan. 9:26)

Then what we need to identify the beginning and the end of the Tribulation appears in Dan. 9:27:

²⁷ Then he shall confirm a ^[k]covenant with many for one week;

But in the middle of the week He shall bring an end to sacrifice and offering.

And on the wing of abominations shall be one who makes desolate,

Even until the consummation, which is determined,

Is poured out on the ^[I]desolate."

The false messiah makes and confirms a covenant with many for the duration of the last week and the middle of the week is identified as the time when the sacrifice and offering (or praise) is stopped and the abomination of desolation is set up [Article 1638: Donald Trump: Antichrist, Beast and the Dragon].

Thus we would expect the Tribulation or the final 7 years to begin on June 28th 2016. Then, in Dan. 12:11-12 we read:

¹¹ "And from the time that the daily sacrifice is taken away, and the abomination of desolation is set up, there shall be one thousand two hundred and ninety days. ¹² Blessed is he who waits, and comes to the one thousand three hundred and thirty-five days. (Dan. 12:11-12)

Which tells us that there is a period of 1290 days from the setting up of the abomination of desolation and gives us a period of 1335 = 1290 + 45 days. And since I knew that there was a delay in the Seasons of about 6 weeks = 42 days by 2014, because the real heat of Summer used to always begin at the end of June in Portugal, when I was child, but by 2014, it was not beginning until August, I deduced that the 45 day period was a time lag, which occurred due to the shortening of each day since the Sun went dark, which I determined occurred by around 1998, but since the Sun could still be turning on now and then whilst being dark most of the time, it most likely went permanently dark in 2001, which goes along with that being the 911 year. This means that the 45 year time lag occurred between 2001 and 2016 and thus over 15 years, thus giving a time lag of 45 days/15 years = 3 d/y.




Figure 1. Diagram showing the information obtained from Dan. 9:24-27 and Dan. 12:11-12. If there is a period of 1290 days from the abomination of desolation to the end we would expect a similar period in the first half. The 1335 day count then gives us the time lag and when the middle of the Tribulation is reached. The 1335 day count also takes us to February 23rd 2020 from June 28th 2016, the day we would expect the Tribulation to begin; it actually began on August 12th 2016.

However, the time lag of 45 days is from 2001 to 2016, we would expect the lag to be in effect until the middle and also from the middle to the end of the tribulation, the two periods being 3.5 years long and thus each producing a lag period of 3.5 years x 3 d/y =10.5 days. Then, the timing of the rapture begins to emerge from Revelation 12 where a woman with a garland of 12 stars gives birth to a Child, who is identified as a the body of Christ, the Child being caught up (same words used to describe the rapture in I Thess. 4:17) to God's throne, after which event the woman is fed for 1260 days in a place prepared by God for her, which will take us to the end of the Tribulation.

⁵ She bore a male Child who was to rule all nations with a rod of iron. And her Child was caught up to God and His throne. ⁶ Then the woman fled into the wilderness, where she has a place prepared by God, that they should feed her there one thousand two hundred and sixty days. (Rev. 12: 5-6)

The difference in the time counts: 1290 – 1260 = 30 days, thus giving an idea that the rapture happens 30 days into the second half of the Tribulation. However, the time lag period still has to be fitted into the timing before a more accurate time can be determined.

Figure 2. Revelation 12 suggests that the rapture occurs 30 days into the second half of the Tribulation. But this is not the end of the calculation because two 10.5 days delay still have to be accounted for.

The first of the 10.5 delays due to the time lag was accounted for by the mid-Tribulation period having been found to be about 11 days long because the abomination of desolation occurred on March 4th 2020.

Services were stopped at the Seoul, South Korea, church called: Temple of the Tabernacle of the **Testimony.** The church was forced to close on Friday February 21st 2020, which stopped its Sunday services on February 23rd 2020, thus stopping the sacrifice of praise and making this the church to watch for the next event mentioned in Dan. 12:11: the setting up of the abomination of desolation. 


Figure 4. The Schincheonji (Temple of the Tabernacle of the Testimony) church's website was hacked on at 9:48 am for 10 minutes and several more times in the afternoon of March 4th 2020 and an image of Buddha was set up on it, which would be the abomination of desolation. The website became inaccessible (killed) at 5:48 pm

(http://www.koreaherald.com/view.php?ud=20200304000 911). This means that the abomination of desolation event was an 8 hour long event which took place on March 4th 2020.

Then the 1290 period mentioned in Dan. 12:11 has to be counted from March 4th 2020. The period of time between February 23rd and March 4th is also 11 inclusive days long and thus accounts for the first of the time lag periods, of 10.5 days, which means there is now only one to account for. Since it is to be expected that the two halves of the Tribulation are exactly the same length we would then have to place the other lag period at the end, the woman being fed right through that period until the end.




Figure 5. The mid-Tribulation period is the exact length of time that we expect the time lag to be over 3.5 years, 10.5 days, which then suggests that there is another such period at the end of the second half of the Tribulation, which then suggests that the woman gives birth 40.5 days after March 4th or April 13th to 14th 2020. The end of the Tribulation is then 1300.5 days from March 4th 2020 and thus on September 25th to 26th 2020.

The other reason why we would expect there to be a waiting period at the end is that the 2 witnesses are killed, suggesting that the website created by the witnesses are terminated 3.5 days before an event when God says 'come up here'. The witnesses prophecy for 1260 days, the same length of time as the woman is fed but because of the 3.5 day period at the end we know that their 1260 days do not coincide with the woman's.

And I will give power to my two witnesses, and they will prophesy **one thousand two hundred and sixty days**, clothed in sackcloth." (Rev. 11:3)

⁷When they finish their testimony, the beast that ascends out of the bottomless pit will make war against them, overcome them, and kill them. ⁸ And their dead bodies will lie in the street of the great city which spiritually is called Sodom and Egypt, where also ^[c]our Lord was crucified. ⁹ Then those from the peoples, tribes, tongues, and nations ^[d]will see their dead bodies three-and-a-half days, and not allow their dead bodies to be put into graves. (Rev. 11:7-9)

The Beast being referred to here, rises out of the bottomless pit or the earth (Rev. 13) and is thus the second Beast, the FALSE PROPHET beast, the one that controls the news media, which suggests that the news media Beast overcomes the 2 witnesses' websites and they and those whom it and the other Beast control through a chip implanted in their bodies gloat over it for 3.5 days. But because of the 3.5 day period, it is the 2 witnesses that we expect to begin their testimony 30 days after March 4th 2020 and to finish their testimony at the end of the 1290 day count.




Figure 6. Diagram with all 3 time lag periods and indicating the timing of the 2 witnesses' testimony, the position of which is still a little uncertain at the time of writing this article.

Figure 7. April 13th to 14th 2020 falls within the Passover time, Passover day 6. Because of the uncertainty pertaining to when exactly to start the count on March 4th 2020 it is not possible to accurately pinpoint the time of the rapture other than being around Passover Day 6. Jesus was resurrected after being 3 days and nights in the grave and thus on Day 4, this would suggest that his body would be resurrected 2 days later, which also agrees with the count where one day is as 1000 years, Jesus was resurrected after 4000 years (Day 4) and His body, after 6000 (Day 6).

The fact that we cannot obtain an exact time for the rapture agrees with what Jesus said is Rev. 16:15:

15 "Behold, I am coming as a thief. Blessed is he who watches, and keeps his garments, lest he walk naked and they see his shame."

Figure 8. The day that the tribulation is supposed to end, September 25th to 26th 2023, according to the calculation, is then found to fall on Yom Kippur, in 2023, which is a confirmation as to the determined timing of events and the rapture.

In conclusion, the timing of events relating to the 7 year Tribulation Period has now been determined from the scriptures starting with the command to rebuild Jerusalem on June 28th 1967, which set the clock running. According to this clock the Rapture is set to happen on April 13th to 14th 2020, Passover Day 6, and the Tribulation is set to end on September 25th to 26th 2023, which happens to be Yom Kippur.


